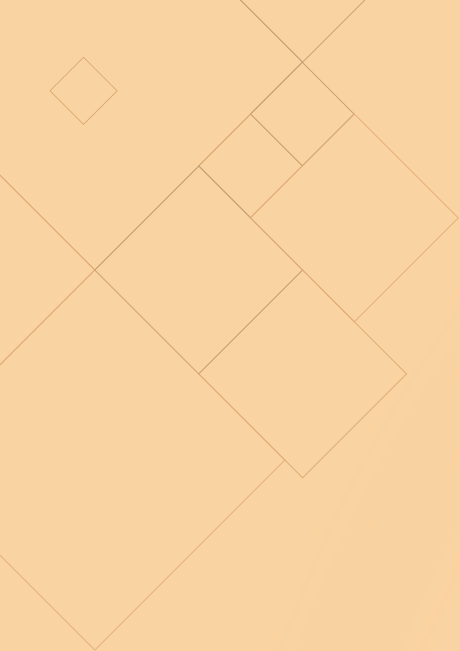

宗旨及參選資格 OBJECTIVE & ELIGIBILITY

宗旨 OBJECTIVE

【進出口企業大獎】的設立是為表揚及鼓勵傑出的進出口企業多年來對香港經濟發展作出的貢獻及努力，藉此表彰優秀企業，分享他們的成功經驗，凝聚及團結業界同仁，激勵大家迎難而上，推動進出口業繼往開來，走上一個新的發展台階。

【進出口企業大獎】分為六大獎項，包括「市場拓展獎」、「企業傳承獎」、「卓越成就獎」、「創業精神獎」、「電子商貿獎」及「優越創新獎」，表揚於不同方面擁有傑出表現的進出口企業。

【The Outstanding Import & Export Enterprise Award】 aims to promote and recognise the tremendous efforts and contributions made by the import and export enterprises for the betterment of the economic development in Hong Kong. The Award continues to pay tribute to the enterprises with outstanding performance and we shall take this opportunity to share their successful experience, unite industry players and enhance the future development of the industry in Hong Kong.

【The Outstanding Import & Export Enterprise Award】 includes six awards, namely Market Development Excellence Award, Corporate Succession Excellence Award, Corporate Achievement Award, Entrepreneurship Award, E-Commerce Award and Innovation Excellence Award, to commend our industrial elites for their excellent achievements in various aspects.

參選資格 ELIGIBILITY

參選企業需符合以下所列資格：

1. 為香港註冊公司，主要業務營運基地設於香港、或設於粵港澳大灣區內；
2. 有直接或間接參與香港進出口業，並對進出口業有顯著的貢獻。

Eligible nominees should meet the below requirements:

1. Hong Kong incorporated companies with principal business in Hong Kong or in Guangdong-Hong Kong-Macao Greater Bay Area;
2. Having a direct or indirect involvement in import and export businesses in Hong Kong, with significant contributions thereto.

評審機制及重要日期

SELECTION PROCESS & IMPORTANT DATES

評審機制 SELECTION PROCESS

由兩大評審團負責，評審委員將根據獎項之評審準則進行以下兩部份評審：

1. 初步甄選

評審委員將依據參選公司提交之報名表格內容及附加資料，以評審準則為本，對每間參選公司進行獨立審核，並挑選符合基本標準的公司進入第二部分評審。入選公司將獲個別通知。

2. 評審會面

進入第二部分評審的公司，將獲安排與評審團會面，透過該公司代表陳述，加上評審團的答問環節，各評審將按評審準則評分，排列優次。獲選公司將獲個別通知。

The selection process will be handled by two judging panels. Members of the judging panel will evaluate the entries through a two-round process:

1. Preliminary Selection

Each entry will be reviewed independently by members of the judging panel based on information stated in the entry form and the supplemental information submitted by the nominee in accordance with the judging criteria. Nominees which reach the basic required standard will be shortlisted and notified individually.

2. Interview with the judging panel

Shortlisted nominees will be invited to attend an interview with the judging panel. The shortlisted nominees will be required to make a presentation to the judging panel, followed by a Q&A session. The shortlisted nominees will then be ranked based on their scores given by the judging panel. Awardees will be notified individually.

- ◆ 通過技術提升或創新產品及服務，例如利用品牌建設、產品創新、電子商貿平台等，提高公司競爭力。

2. 業內商譽



- ◆ 致力建立良好企業形象；
- ◆ 企業成就獲得業界的認同；
- ◆ 對其品牌及商譽具策略性的發展計劃。

3. 社會責任



- ◆ 履行社會企業責任，參與及支持社會服務；
- ◆ 實踐對社會負責的營商手法，如發展環保項目、推動綠色辦公室等；
- ◆ 積極協助推動進出口業整體行業發展。

4. 企業管治



- ◆ 擁有良好公司管治文化及具有領導能力，並配合適當之公司結構及政策；
- ◆ 透過不同渠道與利益相關者維持良好關係，並回應他們的需求及顧慮；
- ◆ 擁有高效的內部監控、風險管理，以及內部和外部審核程序；
- ◆ 企業文化及業務不斷得到傳承及優化。

The judging criteria are as follows:

1. Company Performance



- ◆ Outstanding performance in business development, with an excellent marketing strategy and key business milestones achieved;
- ◆ Stable financial performance with adequate resources to continuously support business development;
- ◆ Enhancing competitiveness of the company by way of technological advancement or product and service innovation, e.g. brand-building, product innovation and e-commerce platform.

2. Reputation



- ◆ Active pursuit of a good corporate image;
- ◆ Industry-wide recognition of corporate achievements;
- ◆ Strategic development of brand and corporate reputation.

3. Corporate Social Responsibility



- ◆ Fulfilling corporate social responsibility, and participating in and supporting social service;
- ◆ Establishing a socially responsibly business practice, e.g. launching environmental protection projects and introducing "Green Office";
- ◆ Making continuous positive contribution to the development of the import and export industry in Hong Kong.

4. Corporate Governance



- ◆ Demonstrating a good corporate culture and effective leadership with support from an appropriate corporate structure and policy;
- ◆ Maintaining good relationships with different stakeholders via different channels and being responsive to their needs and concern;
- ◆ Effective internal control, risk management, as well as internal and external audit;
- ◆ Continued improvement in corporate culture and business.

- ◆ Using information technology in daily operations, e.g. electronic customs declaration, GPS cargo tracking and RFID.

6. Innovation Excellence Award

- ◆ Active pursuit of innovative products and services and exploring new markets;
- ◆ Upgrading and transforming business or enterprise itself by way of technological advancement or establishment of new sales channel;
- ◆ Continued pursuit of innovation research and development e.g. obtaining registered patent and other intellectual property rights.

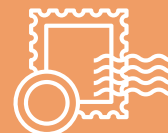

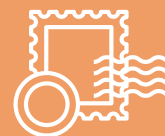
